## 50 YEAR NON-PRO RATA TRANSFERABLE WARRANTY

VPI Building Products warrants that VPI uPVC building boards are free from defects due to faulty manufacture and that for a period of Fifty (50) years from the date of original installation of the product and accessories will be free from defects resulting from faulty manufacture.

If any part of the product fails to conform to the characteristics warranted in paragraph one, VPI Building Products will, at its option either repair or replace (excluding labour) that part of the material found to be defective. Any claims under the warranty will be recognised only after an accredited representative of VPI Building Products has inspected the material and acknowledges in writing that the material is defective, normal weathering, aging and wear and tear excluded.

If a claim is made in respect of a product or a product size and colour that is no longer available, VPI Building Products reserves the right to supply a product that in VPI Building Product's sole discretion is of equal quality or price for the purpose of fulfilling its obligations pursuant to this warranty. Any person to whom product is supplied pursuant to this warranty shall be entitled only to the benefit of the unexpired term of warranty applicable to the product originally installed.

No employee, agent or other person is authorised by VPI Building Products to assume for it any liability in addition to that contained in this warranty statement.

Should you ever need to lodge a warranty claim, VPI Building Products requires evidence of the date of installation of product. VPI Building Products recommends that you retain this warranty paper for such proof of product installation.

The benefit of this warranty will transfer to any new owner if the property upon which the product is installed to the extent that this warranty would have applied to the original owner at date of installation.

This warranty shall only apply to VPI Building Product's uPVC building board and accessories purchased in Australia and New Zealand. This warranty does not cover damage or defect caused by faulty installation. Minor marks which may occur during delivery and installation should be rectified by the installer.

This warranty does not cover damage caused by failure to adhere to the manufactures current installation recommendations, settlement, movement or structural defects of the building, damage caused by the application of paint, fire, hail, flood, lightning or other acts of God, exposure to chemical, pollutants, abrasive materials, radiation from electricity or otherwise from other substances, impact by foreign objects or mistreatment, neglect and insufficient care or failure to follow the recommended cleaning instructions as included below.

This warranty does not exclude or limit any conditional warranty implied or imposed on the Company by virtue of the Trade Practices Act, 1974, or any other statute, rule or regulation except to the extent to which the company is lawfully entitled to exclude or limit it.

### CLEANING INSTRUCTIONS

With very little maintenance, VPI Vinyl Siding can be kept looking clean and new. We recommend that you wash your house 3 times a year to keep the Vinyl Siding's appearance.

Use a long handled soft bristle brush that attaches to your garden hose, start at the top of your house and work down to the bottom to prevent streaking.

If any dirt, grime or soot is present and hard to remove, wipe down the Vinyl Siding with a solution of mild dishwashing detergent and warm water.

DO NOT use any harsh detergent, or products containing bleach or insecticide.
